Declarations of Interest

Disclosable Pecuniary Interest (DPI)

Where a Member has a new or registered DPI in a matter under consideration they must disclose that they have an interest and, unless the Monitoring Officer has agreed in advance that the DPI is a 'Sensitive Interest', explain the nature of that interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a DPI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation permitting them to do so. If during the consideration of any item a Member becomes aware that they have a DPI in the matter they should declare the interest immediately and, subject to any dispensations, withdraw from the meeting.

Other Significant Interest (OSI)

Where a Member is declaring an OSI they must also disclose the interest and explain the nature of the interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a OSI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation to do so or the meeting is one at which members of the public are permitted to speak for the purpose of making representations, answering questions or giving evidence relating to the matter. In the latter case, the Member may only participate on the same basis as a member of the public and cannot participate in any discussion of, or vote taken on, the matter and must withdraw from the meeting in accordance with the Council's procedure rules.

Voluntary Announcement of Other Interests (VAOI)

Where a Member does not have either a DPI or OSI but is of the opinion that for transparency reasons alone s/he should make an announcement in respect of a matter under consideration, they can make a VAOI. A Member declaring a VAOI may still remain at the meeting and vote on the matter under consideration.

Note to the Code:

Situations in which a Member may wish to make a VAOI include membership of outside bodies that have made representations on agenda items; where a Member knows a person involved, but does not have a close association with that person; or where an item would affect the well-being of a Member, relative, close associate, employer, etc. but not his/her financial position. It should be emphasised that an effect on the financial position of a Member, relative, close associate, employer, etc OR an application made by a Member, relative, close associate, employer, etc would both probably constitute either an OSI or in some cases a DPI.

Subject: **i-Tree Eco Survey Update**

Since the last Environment Committee meeting, the Treeconomics participants have been busy surveying their plots.

Of the 29 trainees, only three dropped out before the surveying got underway.

The participants have been split into five groups based on their location. The North Deal team finished their surveying and kindly took on some more plots. These have also been completed, so this team has now finished.

This week we reached a key milestone as we hit halfway with 125 Plots submitted to the i-tree eco software. There are just 37 plots left to be allocated to participants.

We are in regular contact with the teams, keeping them up to date, providing useful tips and support.

Subject: **Air Pollution Plan**

As we approach winter, PM2.5 pollution, the most harmful particulates, will peak. The burning of wood and coal by households in stoves and open fires is a large contributor to emissions of particulate matter and is most common in winter months and during the evenings. Nitrogen dioxide (NO₂) pollution will also rise due to more traffic and overcast skies. Concentrations at roadsides are likely to be 20% greater during the working week compared to the weekend.

Short term regular exposure creates a considerable cumulative risk for regular route users such as children going to school. And it is not just children walking, scooting, or cycling. Children inside vehicles are equally at risk.

So far the Council has:

- Become an official supporter of Clean Air Day
- Created an online Air Pollution Hub

- Purchased and tested a personal air quality monitor
- Launched a “No Idling” Poster Design Competition with local schools

No Idling Poster Design Competition

In June the Mayor wrote to all the local Primary School Headteachers inviting their pupils to take part in the “No Idling” Poster Design Competition. The Competition started at the beginning of this term in September and closes at the end of term on Friday 22 October. Of the nine schools contacted, six are taking part: Deal Parochial; Downs; Hornbeam; Kingsdown with Ringwould; Sandown; & Sholden

The neighbouring Parish Councils have been invited to take part and contribute. So far, none have done so.

Poster design judging will take place week commencing 25 October and poster framing along with school banner production will begin week commencing 1 November. Production & installation of hotspot signs will be in November. The locations include: South Street; Queen Street/West St; Queen St/High St; Western Avenue; & Albert Road. A press release will be issued along with Facebook posts and wording for school newsletters.

Air Quality Monitoring

It has been difficult to achieve regular air quality monitoring (AQM) on school routes at peak times. To help schools understand the impact of their ‘No Idling’ work, we will need to take regular, consistent AQM readings starting as soon as possible.

Recommendation

To request that the Town Clerk assigns members of staff to undertake the Air Quality Monitoring along school commuter routes at peak times, between 8-9am and 3-4pm. Results to be published on the [deal.gov.uk](https://www.deal.gov.uk) Air Pollution Hub

Subject: **Annual Net Zero Review**

Following the work undertaken over the last two years, the initial LGA Carbon Accounting Tool Results and the EPC Recommendations, below is an amended list of actions identified by Councillors and Officers from the Carbon Literacy Training and the Environment Performance Certificate Recommendations to achieve the goal of Zero Carbon Emissions (Green House Gas Emissions) by 2025.

This list:

- is based on the Green House Gas Protocol introduced to the Council at the Carbon Literacy training;
- does not identify funding sources for the necessary activities. Councillors and Officers will need to be on the lookout for future funding opportunities;
- identifies where professionals need to be engaged to undertake specific specialist activities;
- will evolve as more work is carried out and a deeper understanding of the issues around this journey to Net Zero are learnt;
- may make Deal Town Council Energy Positive if localised renewable sources of energy can be deployed;
- does not meet the full ambitions of the Climate Emergency Declaration made in 2019;
- does not address the ecological emergency of the biodiversity collapse.

Request STEM Sustainability to revisit the Council two years after they delivered the carbon literacy training, to review the Town Council’s performance towards its Net Zero Carbon goal against the Green House Gas Protocol model. As well as proposing the annual budgets for approval by Full Council, one of the duties of the Finance & General Purposes Committee is to monitor the agreed budgets and reserves of the Council.

At The last meeting of F&GP a resolution was passed:

RESOLVED: That an extra F&GP meeting is held in December 2021 with the budget for 22-23 as the sole agenda item and that the T&I and Environment committees are requested to create budgets for project funds as requested, to be ready for the November F&GP meeting.

Members will recall that in March 2021 Full Council passed a resolution to rename the Special Projects fund as the 'Environment Fund' that had a balance of £46,000 at that time.

In the 2021-22 budget this fund moved from being a standard budget line into an 'Earmarked reserve', this allowed for any future balances to be automatically rolled over into future years until it was spent without being transferred to general reserve at the end of the financial year.

Subject: **Climate Change Awareness Communication around COP26**

The United Nations Climate Change Conference 2021 (COP26) takes place in Glasgow at the end of this month between 31 October & 12 November.

It is the 26th Conference of the Parties (hence COP26) who signed the Paris Agreement to limit global warming to 1.5 degrees Celsius. The world is not on track to limit global warming to 1.5°.

The key messages from the pre-conference material are that:

- We have to act urgently
- We all have a part to play
- We all have to change
- We all must work together
- We must prioritise nature

In the lead up to and during COP26 we can communicate through our website, Facebook page and the local media, what the Town Council is doing, especially the Council's more challenging target of Zero Carbon emissions with minimal off-setting by 2025. The communications can highlight the framework chosen to the road to zero, how small things can have a big impact and how everything is relevant to achieve Net Zero, not just energy, but also our purchases, behaviour and waste.

Recommendation

Create a Communication Plan to ensure the Town Council shares the work it is doing to achieve Net Zero for the benefit of the residents, workers and businesses in Deal.

Sainsburys Green Spaces:

As requested by committee I have been in contact with the Manager of Deal Sainsburys to discuss their plans for planting in their car park and nearby surrounding areas. The Manager has confirmed he is able to meet with myself and Cllr Thompson and I am currently in the process of agreeing a time and date for this.

Victoria Park:

As requested by committee Councillor Oliver and I met with Mr Roger Wragg Head of Commercial Services at **Dover District Council**, to further discuss the committees request that Victoria Park has the Fields In Trust protection placed on it.

This proved a very interesting meeting. Mr Wragg clarified the officer position on Victoria Park which is that Victoria Park is already sufficiently protected from development and that if trust status were applied it might restrict any flexibility they may wish to have in the future. After hearing about our motivations for seeking this additional layer of protection – namely to ensure that development is prohibited beyond the life of the current administration / local plan and to act as a pilot for gaining this protection for other parks and green spaces that are potentially at greater risk - he said he would consider it with his team and respond with a yes, yes with caveats or a no.

Mr Wragg advised that other green spaces/parks in Deal for which DDC is the landowner could also be considered for Fields in Trust protection, i.e. North Deal Playing Field. He also advised that they would consider requests from Deal Town Council to take ownership of parts of their green spaces to plant trees, community orchards, outside gyms etc provided that there was a clear plan for financing, managing and maintaining them.

During the discussion we also learned that the trees at Victoria Park, along Mill Road, are scheduled for removal, the reason given was because they had reached the end of their life. He advised that this area was an issue for buses using the road, and that there was no clear boundary. Councillor Oliver asked that hedging along that route be considered rather than fencing and that Deal Town Council's input be sought on changes and improvements to the park as the Environment Committee has a very strong interest in this.

Recommendations:

- Members to discuss and consider other areas that may benefit from Fields in Trust protection.
- The committee request DDC supply more information on the health of the trees identified for removal due to end of life in Victoria Park
- The committee request that hedging is planted along the Victoria Park/Mill Road boundary
